

**Important Notice Regarding Registration with the Service d'Education et d'Accueil de Stadtbredimus (SEAS) for the 2026–2027 School Year**

Dear Parents and Guardians,

I am writing to provide you with information regarding the enrollment of your child(ren) at SEAS Stadtbredimus for the 2026–2027 school year.

**The registration agreement will be available starting April 14, 2026**

In light of the new regulations, we ask that you come to SEAS Stadtbredimus to sign an enrollment agreement for your child(ren):

**From 8:00 a.m. to 10:30 a.m. or from 3:00 p.m. to 5:30 p.m.**

- **Thursday**                **April 23, 2026**

During the times listed above, SEAS staff will be on hand to provide you with information about how the childcare program works and to help you fill out the registration form for your child(ren).

**Children attending daycare for the first time can be registered starting Tuesday, September 1, 2026**, so they can get used to the daily routine at daycare before school starts on September 15. You will receive a registration form for the summer break along with your registration confirmation.

**The following documents must be included with the application form:**

- **Employment certificates** from your legal representatives that **are no more than 3 months old** and confirm that you are employed, as well **as stating your weekly working hours**, or a certificate of registration with ADEM.
- **A copy of the child's social security card.**
- If applicable, **a current medical certificate** attesting to allergies and/or intolerances. • Für Kinder mit besonderen gesundheitlichen Bedürfnissen: der individuelle Betreuungsplan und der Notfallplan



- **A copy of the child's vaccination** record. Legal guardians are responsible for ensuring that the copy of the vaccination record is up to date. The Luxembourg Red Cross does not conduct vaccination checks. The collection of this data is mandated by the Health Inspection Department of the Ministry of Health.
- If applicable, a **copy of the court judgment** or temporary order regarding parental custody.
- **Appendix 1 or 2:** Form regarding regular or irregular attendance in the basic plan (during the school year)
- **Appendix 6:** A properly completed and signed direct debit authorization form, along with bank account information, for new registrations or if your bank account information has changed.
- **Appendix 8:** Consent to the recording and/or publication of visual material (photos or videos) for minor children under 13 years of age
- **Appendix 11:** Consent to use the "DIMMI" app

**Please make sure your documents are complete, as only complete sets of documents will be considered. Please bring all required documents with you and have this contract signed by both legal representatives.**

If the number of enrollment applications exceeds the maximum capacity for children set by the Ministry of Family Affairs in accordance with the Grand Ducal Regulation of July 20, 2005, priority will be given to families in which both parents work full-time or are registered with ADEM, single-parent families, and low-income families.

**The date of submission of the registration form** will be the deciding factor if the total number of registrations exceeds the maximum capacity and multiple registrations meet the same eligibility criteria.

**The registration form must be submitted by April 30, 2026, at the latest.**  
**You will receive a final confirmation regarding your child's registration via email within 5 business days.**
